



**August 2019 Promotion & Free Draw Terms and Conditions:
'Book one of Travel Queen January to March 2020 Thailand Adventure tours during August 2019 for
your chance to win £500 spending money on the trip'**

1. The promoter is Travel Queen LTD (company registration number 10752513) registered at 26 Govan Street, Manchester, M22 4HA.
2. Entry is open only to female residents of the United Kingdom aged 20 to 59 years (as this represents the age group for Travel Queen LTD tours) who book onto one of the following Travel Queen LTD Thailand Adventure tours: 11-25 January 2020, 22 February – 7 March 2020, 21 March – 4 April 2020, by making a tour deposit payment of the standard amount of £295.00 to Travel Queen LTD in one of the following standard methods: online through www.travel-queen.co.uk, over the phone with Travel Queen on 0333 577 5833 or by sending a bank payment to Travel Queen's TTA Trust Account, between 4 and 31 August 2019.
3. The rules of the draw, how to enter and how the winner will be chosen are as follows:
Once a place on one of the above tours has been booked, between 4 and 31 August 2019, entrants must post a fun picture of themselves to the Travel Queen Facebook or Instagram page, share within their post which of the tours above they have booked onto and tag @TravelQueenLTD in their post. All tour bookings and entries must be made as described above by 31 August 2019 in order to enter. The winner will be selected by a draw on 7 September 2019 then contacted directly on the same date. The winner will be announced on www.travel-queen.co.uk and on the Travel Queen Facebook and Instagram pages.
